Freedom of Information Act (FOIA) Request - 230607016

Thank you for your request dated 7 June 2023 in which you asked for the following information from the Ministry of Justice (MoJ):

The number of applications to the secretary of state for pre-tariff sifts before the parole reviews each month since June 2021 and, for each month, the outcome of each of those applications.

I understand that you have received a response to your recent Freedom of Information Request on 07 July 2023. However, it has come to our attention that some of the information provided to you was incorrect. I apologise for this and have provided an amended response below. For ease, I have highlighted the figures which have been corrected.

Your request has been handled under the FOIA.

We have introduced a set of landmark reforms designed to restore public confidence in the parole system, including a tougher Parole Board release test to ensure prisoners who still pose a risk are kept behind bars and a new power for the Justice Secretary to block the release of the most dangerous offenders in the interests of public safety.
